Description of services and/or supplies to be provided:

Immediate expenditure is necessary for repairs to State property to protect against further loss or damage. As a result of a winter with extreme freeze/thaw cycles and excessive moisture we have experienced an excessive amount of potholes and pavement deterioration. These conditions are creating a traffic hazard causing vehicles to have tire blowouts or swerve into adjacent lanes potentially causing accidents. We have had numerous complaints/claims.

The work includes inlaying the pavement and associated repairs on I-74 from west of Ogden to west of Fithian in Champaign and Vermilion Counties which includes approximately 1.9miles of proposed repair locations within this 4.37mile segment.
