The **Illinois Department of Transportation** (“State”) requests Bids from responsible vendors to meet its needs. A brief description is set forth below for Bidder’s convenience, with detailed requirements in subsequent sections of this solicitation. If interested and able to meet these requirements, the State appreciates and welcomes a Bid.

**Brief Description:**

The Illinois Department of Transportation (IDOT) is requesting bids for the services of Vendor(s) to assist **IDOT District 7** in providing land acquisition services to support the Department in delivering the land acquisition program needed for highway projects. Anticipated areas of work and positions needed include: **Project Manager, Appraisal Manager, Appraiser, Appraisal Report, Appraisal Trainer, Review Appraisal Certification Report, Review Appraiser, Specialty Report.** Property Manager, Negotiation and Negotiator, and Relocation and Relocation Agent work must be performed by individual(s) listed on the State’s approved “Fee/Specialty Agent” list, in accordance with the Land Acquisition Policies and Procedures Manual (LAPPM). The District will manage the contract and assign the work on a work order basis. The Vendor(s) shall perform the services required under the Contract in accordance with the most recent editions of the Land Acquisition Policies and Procedures Manual (<http://idot.illinois.gov/Assets/uploads/files/Doing-Business/Manuals-Guides-&-Handbooks/Highways/Land-Acq/Land%20Acquisition%20Manual.pdf>) , the Illinois Highway Code (605 ILCS 5/), the Illinois Eminent Domain Act (735 ILCS 30/), the Code of Federal Regulations, Title 49 CFR Part 24 – Uniform Relocation Assistance and Real Property Acquisition for Federal and Federally-Assisted Program and any other relevant State or Federal laws and regulations. In case of a conflict between the references, the Vendor shall identify them to the Department and follow the instructions furnished by the Department.

It is the goal of this procurement that the selected Vendor(s) will achieve a minimum percentage of the total contract of 10% participation by Disadvantaged Business Enterprises (DBE).

The resulting contract with the awarded Bidder(s) shall have an initial term of three (3) years. In no event will the total term of the contract, including the initial term, any renewal terms, and any extensions exceed ten (10) years. 30 ILCS 500/20-60. Subject to the maximum total term limitation, Agency has the option to renew for the following terms: 12 months.

Please read the entire solicitation package and submit a Bid for evaluation in accordance with the instructions. All forms and signature areas contained in the solicitation package should be completed in full and submitted along with the price proposal which will constitute the Bid. If submitting your Bid in paper format and by mail, do not submit the instructions pages with bids. Bidders should keep the instructions and a copy of their bids for future reference.

All Bids will be open to the public under the Illinois Freedom of Information Act (FOIA) (5 ILCS 140) and other applicable laws and rules, unless Bidder requests in its Bid that the State treat certain information as confidential. A request for confidential treatment will not supersede the State’s legal obligations under FOIA. The State will not honor requests to keep entire Bids confidential. Bidders must show the specific grounds in FOIA or other law or rule that support confidential treatment. Regardless, the State will disclose the successful Bidder’s name, the substance of the Bid, and the price.

the provisions identified by section number for which it seeks confidential treatment and identify the statutory basis or bases under Illinois law, including a detailed justification for exempting the information from public disclosure. Bidder must label the attachment as “Redacted” and return it in Packet 1.

Bidder will hold harmless and indemnify the State for all costs or damages associated with the State defending Bidder’s request for confidential treatment. Bidder agrees that the State may copy the Bid to facilitate evaluation, or to respond to requests for public records. Bidder warrants that such copying will not violate the rights of any third party.

**A.17 RESERVATIONS:** Bidder must read and understand the solicitation and tailor the Bid and all activities to ensure compliance. The State reserves the right to amend the solicitation, reject any or all bids, award by item, group of items, or grand total, and waive minor defects. The State may request a clarification, inspect Bidder’s premises, interview staff, request a presentation, or otherwise verify the contents of the Bid, including information about subcontractors and suppliers. The State will make all decisions on compliance, evaluation, and terms and conditions, and shall make decisions in the best interests of the State and in accordance with the Illinois Procurement Code (30 ILCS 500/), associated administrative rules and other applicable State and Federal statutes and regulations. This competitive process may require that the Bidder provide additional information or otherwise cooperate with the State. If a Bidder does not comply with requests for information or cooperate, the State may reject the Bid as Non-Responsive to the solicitation. Submitting a Bid does not entitle the Bidder to an award or a contract. Posting a vendor’s name in a Bulletin notice does not entitle the vendor to a contract. The State is not responsible for and will not pay any costs associated with the preparation and submission of any Bid. Awarded vendor(s) shall not commence and will not be paid for any billable work undertaken prior to the date all parties execute the contract, unless approved in writing in advance by the State Purchasing Officer or the Chief Procurement Officer (or designee).

**A.18 AWARD:** The State is not obligated to award a contract pursuant to this solicitation. If the State issues an award, the award will be made to the Responsive and Responsible Bidder who submits the lowest price. The State will post a notice to the Bulletin identifying the apparent low-cost Bidder. The State may accept or reject a Bidder’s Bid as submitted or may require contract negotiations. If negotiations do not result in an acceptable agreement, the State may reject the Bidder’s Bid and begin negotiations with another Bidder. Awards are not final until all protests are resolved.

- 1.2.4. **APPRAISAL REPORT** - The Vendor shall provide Appraisal reports to be prepared in the formats outlined and in accordance with the LAPPM and must consider the following:
  - 1.2.4.1. The Vendor shall provide an “Appraiser Team” consisting of no less than 2 Appraisers to perform the Appraisal Reports required per this contract.
  - 1.2.4.2. The Appraisal Report shall be performed by an Appraiser on the State’s Fee/Specialty Agent Appraiser list in accordance with the LAPPM. The appraisal report format to be used shall be based on the Appraiser and State concurrence. Determinations of fair market value performed by the Appraiser shall be in accordance with the LAPPM.
  - 1.2.4.3. The Appraiser shall be an Illinois Certified General Real Estate Appraiser or an Illinois Certified Residential Real Estate Appraiser.
  - 1.2.4.4. The property to be appraised is to be acquired by fee simple, dedication, permanent easement, or temporary easement as

determined and shown on the right of way plan and plat furnished by the State.

- 1.2.4.5.** The Appraisal Report may require the Appraiser to perform work utilizing the State's Land Acquisition System (LAS) and will require input into the system, such as retrieving parcel information such as title work, plat and appraisal, as well as uploading of documents and utilizing the system to produce work documents such as, but not limited to, Appraisal Reports, comparable sales brochures, and other valuation documents/letters/ correspondence required.
- 1.2.4.6.** The Appraisal Report will require the Appraiser to make a detailed inspection of the properties and complete any investigations and studies necessary to derive sound conclusions for the preparation of appraisal reports.
- 1.2.4.7.** The Appraisal Report will require the Appraiser to prepare a comparable sales brochure in accordance with the LAPPM for each project, as requested by the State.
- 1.2.4.8.** The Appraisal Report will require the Appraiser to provide a detailed narrative analysis, a land only and/or improved sales comparison grid is not required but is an option for the Appraiser to use.
- 1.2.4.9.** The Appraisal Report will require the Appraiser to include land and improvement allocations in the comparable sales data section of all appraisals, as requested by the State.
- 1.2.4.10.** On parcels that require the acquisition of a residence, the Appraisal Report may require the Appraiser to perform additional analysis to determine an allocated value for the residence and home site (carve out) as separate from the whole parcel to be acquired. This would be needed for relocation purposes and is not to be included in the appraisal report. The cost for the additional appraisal analysis will be included in the price established in the work order for that Appraisal Report.
- 1.2.4.11.** It may be necessary for a completed appraisal report to be updated for condemnation purposes or revised due to a change in the Right of Way (ROW) plat or due to new information provided by the State. These updates or revisions will be assigned to the Appraiser in a separate work order as the need arises. An Appraiser's revision of the appraisal due to the Review Appraiser's comments or corrections does not constitute an update or revision that would necessitate a separate work order.
- 1.2.4.12.** See Section 2 Table B for additional information on the pay items proposed to do the work.

**1.2.5. APPRAISER** - The Vendor shall establish an Appraiser position whereby this individual shall be responsible for the Appraisal Report related activities assigned by the Department and must consider the following:

- 1.2.5.1.** The Vendor shall provide at least 2 individuals to perform the Appraisal Reports required per this contract with at least 5 years of knowledge and experience in negotiating parcels of land needed for a highway

project under threat of eminent domain on State projects and Local Public Agency projects, utilizing federal funding.

**1.2.5.2.** The Appraiser shall be on the State's Fee/Specialty Agent Appraiser list in accordance with the LAPPM. The main duties/responsibilities of the Appraiser are listed but not limited to those stated in Section 1.2.4.

**1.2.5.3.** The Appraiser must produce a quality product.

**1.2.5.4.** The Appraiser is responsible for the all Appraisal Reports assigned to him/her and needed for State projects.

**1.2.5.5.** The Appraiser must establish schedules for completion of each Appraisal Report assigned, with an anticipated tentative parcel acquired date in mind, to be provided to the Project Manager and/or State.

**1.2.5.6.** The Appraiser may request or be asked by the State to attend project meetings when needed to discuss the overall project scope and/or specific parcel issues with necessary department staff, of which work shall be considered part of an Appraisal Report.

**1.2.5.7.** Appraiser duties that are not included in the work required to complete an Appraisal Report as defined in Section 1.2.4., shall be paid at an hourly rate. Some of these duties are listed below:

**1.2.5.7.1** If requested, attendance at a State public project meeting/hearing to assist district land acquisition staff.

**1.2.5.7.2.** If parcel goes to condemnation, eminent domain court testimony/deposition is required as well as reasonable time needed to prepare for testimony such as phone calls/meetings with the Special Assistant Attorney General, attorney representing the Department in condemnation proceedings.

**1.2.6. REVIEW APPRAISAL CERTIFICATION REPORT** - The Vendor shall provide Review Appraisal Certification Reports to be prepared in the format outlined below and in accordance with the LAPPM and must consider the following:

**1.2.6.1.** The Vendor shall provide a "Review Appraiser Team" consisting of no less than 2 Review Appraisers to perform the Review Appraisal Certification Reports required per this contract.

**1.2.6.2.** The Review Appraisal Certification Report shall be performed by an Appraiser, a "Review Appraiser" on the State's Fee/Specialty Agent Review Appraiser list in accordance with the LAPPM.

**1.2.6.3.** The Review Appraiser shall have no less than 5 years of knowledge and experience in all aspects of eminent domain appraising. Number of years' experience working on State projects, listed on resume, may be considered as part of the evaluation criteria.

**1.2.6.4.** The Review Appraiser shall be an Illinois Certified General Real Estate Appraiser or an Illinois Certified Residential Real Estate Appraiser.

**1.2.6.5.** The Review Appraisal Certification Report may require the Review Appraiser to perform work utilizing the State's Land Acquisition System (LAS) and will require input into the system, such as retrieving parcel

information such as title work, plat and appraisal, as well as uploading of documents and utilizing the system to produce work documents such as, but not limited to, Review Appraisal Certification Reports, and other valuation documents/letters/correspondence required for the Review Appraisal Certification Report.

**1.2.6.6.** It may be necessary for a completed Review Appraisal Certification Report to be updated due to a change in the right of way plat or due to new information provided by the State. These updates or revisions will be assigned to the Vendor in a separate work order as the need arises. A Review Appraiser's second or other subsequent review of an Appraisal Report, rewritten by the Appraiser due to the Review Appraiser's comments or corrections, does not constitute an update or revision to the Appraisal Review Certification Report nor would necessitate a separate work order.

**1.2.6.7.** See Section 2 Table B for additional information on the pay items proposed to do the work.

**1.2.7. REVIEW APPRAISER** - The Vendor shall establish a Review Appraiser position whereby this individual shall be responsible for the Review Appraisal Certification Report related activities assigned by the Department and must consider the following:

**1.2.7.1.** The Vendor shall provide at least 2 individuals to perform the Review Appraisal Certification Reports required per this contract with at least 5 years of knowledge and experience in completing Review Appraisal Certification Reports on parcels of land needed for a highway project under threat of eminent domain on State projects and Local Public Agency projects, utilizing federal funding.

**1.2.7.2.** The Review Appraiser shall be on the State's Fee/Specialty Agent Review Appraiser list in accordance with the LAPPM.

**1.2.7.3.** The main duties/responsibilities of the Review Appraiser are listed but not limited to those stated in Section 1.2.4.

**1.2.7.3.1.** The Review Appraiser must produce a quality product.

**1.2.7.3.2.** The Review Appraiser is responsible for the all Review Appraisal Certification Reports assigned to him/her and needed for State projects.

**1.2.7.3.3.** The Review Appraiser must establish schedules for completion of each Review Appraisal Certification Report assigned, with an anticipated tentative parcel acquired date in mind, to be provided to the Project Manager and/or State.

**1.2.7.4.** The Review Appraiser may request or be asked by the State to attend project meetings when needed to discuss the overall project scope and/or specific parcel issues with necessary department staff, of which work shall be considered part of a Review Appraisal Certification Report.

**1.2.7.5.** Review Appraiser duties that are not included in the work required to complete a Review Appraisal Certification Report as defined in Section

1.2.6., shall be paid at an hourly rate. Some of these duties are listed below:

**1.2.7.5.1.** If requested, attendance at a State public project meeting/hearing to assist district land acquisition staff.

**1.2.7.5.2.** If parcel goes to condemnation, and eminent domain court testimony/deposition is required as well as reasonable time needed to prepare for testimony such as phone calls/meetings with the Special Assistant Attorney General, attorney representing the Department in condemnation proceedings.

**1.2.8. SPECIALTY REPORT** The Vendor shall provide for a Specialty Report to be performed and completed in accordance with the LAPPM and must consider the following:

**1.2.8.1.** The Specialty Report will require work to be performed by a Specialty Agent, who is typically a Professional Engineer, Professional Structural Engineer, Professional Land Surveyor, Architect, or appropriately licensed person(s) in that specific field where more investigation/study is required to complete the valuation of a parcel; a Specialty Agent may be employed by the Vendor.

**1.2.8.2.** The Specialty Agent shall have no less than 5 years of knowledge and experience in their specialty field.

**1.2.8.3.** The Specialty Agent shall be licensed and registered in the state of Illinois in their respective specialty fields: examples (Professional Engineer, Professional Structural Engineer, Professional Land Surveyor, Architect).

**1.2.8.4.** If the Vendor does not have a qualified Specialty Agent to perform and complete the required task, the Vendor may then employ the services of a Sub-contractor, who must be approved by the State.

**1.2.8.5.** The Specialty Agent shall make sufficient inspection of the properties and make such investigations and studies necessary to derive sound conclusions to support the Specialty Report. The following information must be included in the Specialty Report:

- Identification of the property and its ownership.
- Route – Section – Federal Project
- Job Number – County – Parcel Number
- Purpose of report

**1.2.8.6.** It is the Specialty Agent's responsibility to ensure that all items affecting the value of the parcel have been considered in the specialty report.

**1.2.8.7.** The Specialty Report may require the Specialty Agent to perform work utilizing the State's Land Acquisition System (LAS) and will require input into the system, such as retrieving parcel information such as title work, plat and appraisal, as well as uploading of documents and utilizing the system to produce work documents such as, but not limited to, Specialty Agent Reports, and other engineering, surveying, or valuation documents/letters/correspondence required for the Specialty Report.

**1.2.8.8.** It may be necessary for a completed Specialty Report to be updated or revised by the Specialty Agent due to a change in the ROW plat or due to new information provided by the State. These updates or revisions

will be assigned to the Vendor in a separate work order as the need arises.

**1.2.8.9.** See Section 2 Table B for additional information on the unit cost pay item. Unit cost to be negotiated based on complexity of the parcel assignment and shall be approved by the Central Bureau of Land Acquisition prior to the Vendor commencing work.

**1.2.9. NEGOTIATION** - The Vendor shall conduct the Negotiation of a right of way parcel needed for a State project. This work is to be performed by a Negotiator, and all Negotiations must be completed in accordance with the current LAPPM and will consider the following:

**1.2.9.1.** The Vendor shall provide a "Negotiation Team" consisting of no less than 2 Negotiators to conduct the Negotiation of right of way parcels needed for State highway projects. The Negotiation shall be performed by a Negotiator on the State's Fee/Specialty Agent Negotiator list in accordance with the LAPPM.

**1.2.9.2.** Negotiator shall work with the Project Manager and/or State to receive and understand the scope of work for each work order and the associated deadlines/time frames involved.

**1.2.9.3.** The Negotiator must maintain effective communication with all parties involved regarding issues that arise on parcels.

**1.2.9.4.** The Negotiation shall begin at the direction of the State, with the Negotiator acknowledging the start date provided by the State to commence the Negotiation process, the State approval of the Appraisal report, and the State Phase 1 Approval for the project.

**1.2.9.5.** The Negotiation may require the Negotiator to perform work utilizing the State's Land Acquisition System (LAS) and will require input into the system, such as retrieving parcel information such as title work, plat and appraisal, as well as uploading of documents and utilizing the system to produce work documents such as, but not limited to, conveyance documents, Negotiator reports, and State letters/correspondence required for the Negotiation.

**1.2.9.6.** The Negotiation will require the Negotiator to adequately present an offer to the property owner. Personal face to face contact should take place if feasible. The property owner should be properly informed of the details of the acquisition and the effect of the acquisition on the property as outlined in the LAPPM. The Negotiation will require the Negotiator to document fully all efforts made to acquire the parcel in the Negotiator's Report in the format accepted by the State.

**1.2.9.7.** The Negotiation may require the Negotiator to recommend an Administrative Settlement, as outlined in the LAPPM. Administrative Settlements will be determined by the State on an individual parcel basis; the State may direct the Vendor's Project Manager to draft the Administrative Settlement for a parcel.

**1.2.9.8.** After having made every reasonable effort to negotiate with the owner of a parcel, if the Negotiator is still unable to obtain all the required documents, at the direction of the State, the Negotiation requires the Negotiator to prepare and submit a copy of the latest Negotiator's

Report completed to date with the names and addresses of all interested parties. In addition, if necessary and requested, the Negotiator's Report shall include a recommendation from the Negotiator for further action as well as the documents required for the request for eminent domain action. Even though eminent domain action has been requested, the Negotiation requires the Negotiator to make continued efforts to settle until the actual filing date of the petition to condemn the parcel.

**1.2.9.9.** The State may provide new information to the Vendor after the Negotiator has made their first contact with the property owner. In this instance, the Vendor will be required to revise negotiation documents, which would require a new offer or an updated Negotiation of the parcel. These updates will be assigned to the Negotiator in a separate work order as the need arises. Any additional work for the Negotiation of the parcel, required to obtain title approval for the Vendor, does not constitute an update or revision that would necessitate a separate work order.

**1.2.9.10.** See Section 2 Table B for additional information on the pay item unit cost required to do the work.

**1.2.10. NEGOTIATOR** - The Vendor shall establish a Negotiator position whereby this individual shall be responsible for all negotiation related activities assigned by the Department and must consider the following:

**1.2.10.1.** The Vendor shall provide at least 2 individuals to perform the Negotiations required per this contract with at least 5 years of knowledge and experience in negotiating parcels of land needed for a highway project under threat of eminent domain on State projects and Local Public Agency projects, utilizing federal funding.

**1.2.10.2.** The Negotiator shall be on the State's Fee/Specialty Agent Negotiator list in accordance with the LAPPM.

**1.2.10.3.** The Negotiator shall act as the State's representative to the property owner(s).

**1.2.10.4.** The main duties/responsibilities of the Negotiator are listed but not limited to those stated in Section 1.2.9.

**1.2.10.5.** The Negotiator must produce a quality product and perform QA/QC on parcel file documents required for submittal to the State.

**1.2.10.6.** The Negotiator is responsible for the acquisition/negotiation process required for all Negotiations assigned to him/her and needed for State projects.

**1.2.10.7.** The Negotiator must establish schedules for each activity/milestone needed for the parcel's acquisition, with an anticipated tentative parcel acquired date in mind, to be provided to the Project Manager and/or State to acknowledge the State's Letting date for the construction project scheduled.

**1.2.10.8.** The Negotiator may request or be asked by the State to attend project meetings when needed to discuss the overall project scope and/or specific parcel issues with necessary department staff, of which work shall be considered part of a Negotiation.



**1.2.10.9.** Negotiator duties that are not included in the work required to conduct a Negotiation as defined in Section 1.2.9. shall be paid at an hourly rate. These duties are listed below:

**1.2.10.9.1.** If requested, attendance at a State public project meeting/hearing to assist district land acquisition staff.

**1.2.10.9.2.** If parcel goes to condemnation, and eminent domain court testimony/deposition is required as well as reasonable time needed to prepare for testimony such as phone calls/meetings with the Special Assistant Attorney General, attorney representing the Department in condemnation proceedings.

**1.2.11. RELOCATION:** The Vendor shall conduct the Relocation of a right of way parcel needed for a highway project. This work will be performed by a Relocation Agent, and all Relocations must be completed in accordance with the LAPPM and must consider the following:

**1.2.11.1.** The Relocation will be completed by a Relocation Agent, who must be on the State's "Approved Fee/Specialty Agent List" for Relocation Agents in accordance with the LAPPM.

**1.2.11.2.** The Relocation Agent shall have no less than 5 years of knowledge and experience in all aspects of the relocation of property needed for a highway purpose including the State's relocation assistance and payments program. Number of years' experience working on State projects, listed on resume, may be considered as part of the evaluation criteria.

**1.2.11.3.** The Relocation requires the Relocation Agent to be the State's representative to the property owner.

**1.2.11.4.** The Relocation will require the Relocation Agent to work with the Project Manager and/or State to receive and understand the scope of work for each work order and the associated deadlines/time frames involved.

**1.2.11.5.** The Relocation shall require the Vendor to establish schedules for each activity/milestone needed for a Relocation of a parcel for a Department project. Progress shall be reported to the Project Manager and/or State to assure a quality product.

**1.2.11.6.** The Relocation requires communication, including but not limited to relocation interviews, by the Relocation Agent with all parties involved regarding issues that arise on the parcel(s).

**1.2.11.7.** The Relocation may require the Relocation Agent to perform work utilizing the State's Land Acquisition System (LAS) and will require input into the system, such as retrieving parcel information such as title work, plat and appraisal, as well as uploading of documents and utilizing the system to produce work documents required to complete the Relocation.

**1.2.11.8.** The Relocation requires the Relocation Agent to produce a quality product.

- 1.2.11.9.** For each Relocation of a parcel, the Relocation Agent shall be required to provide relocation assistance, advisory services, and determine the amount of payments to be provided to every displaced person(s).
- 1.2.11.10.** For each Relocation, the Relocation Agent shall be required to personally contact the property owner and/or occupant(s) at the onset of the relocation process, present the appropriate informational letter, and provide information about the relocation advisory assistance and payments that will be made available to them. The Relocation Agent is required to remain in continual personal contact with the displaced person(s) throughout the relocation process to assist in their relocation. A log of each contact will be maintained on an ongoing basis as part of the Relocation Assistance Unit Record.
- 1.2.11.11.** For each Relocation, the Relocation Agent shall submit all computations for replacement housing payments and requests for housing of last resort payment to the State for review and approval prior to initiation of negotiations.
- 1.2.11.12.** For each Relocation, the Relocation Agent shall maintain an accurate and up-to-date file for each relocation unit, including moving expense records, replacement housing payment records, all relevant correspondence and the Relocation Assistance Unit Record. This file will be provided to the State upon completion of the relocation for that unit.
- 1.2.11.13.** All relocation claims, along with their necessary supporting documentation, shall be submitted to the State by the Relocation Agency for review and final approval.
- 1.2.11.14.** If the Relocation has any disputed claims, the Relocation Agent shall forward all written requests for review of disputed relocation claim(s) to the State.
- 1.2.11.15.** It may be necessary for a Relocation of a parcel to be revised, due to a change in the ROW plat or due to new information provided by the State, which would require a Relocation Addendum. The Relocation Addendum will be assigned to the Vendor in a separate work order as the need arises.
- 1.2.11.16.** See Section 2.2 for additional information on the unit cost pay item. Unit cost for the Relocation and if required Relocation Addendum(s) for a parcel is to be negotiated and agreed upon by the State and Vendor based on complexity of the parcel assignment and shall be approved by the Central Bureau of Land Acquisition prior to the Vendor commencing work.

**1.2.12. RELOCATION AGENT** - The Vendor shall establish a Relocation Agent position whereby this individual shall be responsible for all Relocation related activities assigned by the State and must consider the following:

- 1.2.12.1.** The Vendor shall provide at least 2 individuals to perform the Relocations required per this contract with at least 3 years of knowledge and experience in relocating parcels of land needed for a highway project under threat of eminent domain on State projects and Local Public Agency projects, utilizing federal funding.

- 1.2.12.2.** The Relocation Agent shall be on the State's Fee/Specialty Agent Relocation Agent list in accordance with the LAPPM.
- 1.2.12.3.** The Relocation Agent shall act as the State's representative to the property owner(s).
- 1.2.12.4.** The main duties/responsibilities of the Relocation Agent are listed but not limited to those stated in Section 1.2.11.
- 1.2.12.5.** The Relocation Agent must produce a quality product.
- 1.2.12.6.** The Relocation Agent is responsible for the relocation process required for all Relocations assigned to him/her and needed for State projects.
- 1.2.12.7.** The Relocation Agent must establish schedules for each activity/milestone needed for the parcel's relocation, with an anticipated tentative parcel acquired date and vacation date in mind, to be provided to the Project Manager and/or State.
- 1.2.12.8.** The Relocation Agent may request or be asked by the State to attend project meetings when needed to discuss the overall project scope and/or specific parcel issues with necessary department staff, of which work shall be considered part of a Relocation.
- 1.2.12.9.** Relocation Agent duties that are not included in the work required to conduct a Relocation as defined in Section 1.2.11, shall be paid at an hourly rate. These duties are listed below:
  - 1.2.12.9.1.** If requested, attendance at a State public project meeting/hearing to assist district land acquisition staff.
  - 1.2.12.9.2.** If parcel goes to condemnation, eminent domain court testimony/deposition is required as well as reasonable time needed to prepare for testimony such as phone calls/meetings with the Special Assistant Attorney General, attorney representing the Department in condemnation proceedings.

**1.2.13. PROPERTY MANAGER** - The Vendor shall establish a Property Manager who will be responsible for all or some of the State's property management activities, and shall perform work in accordance with the LAPPM and must consider the following:

- 1.2.13.1.** The Property Manager shall have no less than 5 years of knowledge and experience in all aspects of the property management field.
- 1.2.13.2.** The Property Manager may be required to work from the District office upon request from the District.
- 1.2.13.3.** The main duties of the Property Manager may include, at the direction of the State:
  - 1.2.13.3.1.** The Property Manager will be assigned property management work during the acquisition of parcel(s) and prior to construction of the State's project that may include inspection of the properties and preparing inventories.
  - 1.2.13.3.2.** The Property Manager shall establish property owner retention values and rentals for existing occupants, prepare rental agreements as needed, and oversee the vacation and possession of the acquired property.

- 1.2.13.3.3.** The Property Manager shall oversee the management of acquired property not needed immediately for construction purposes may include the rental of land and buildings, maintenance of rental properties, public sale of buildings and improvements, and the demolition of buildings.
- 1.2.13.3.4.** The Property Manager shall oversee ongoing property management of Non-Operating Right Of Way (NORWAY), which will include updating the inventory in the NORWAY database and may include the disposal of excess land or rights in land no longer needed for state highway purposes using the appropriate statutory method of disposal, which would require State review and approval.
- 1.2.13.3.5.** The Property Manager shall oversee the management of operating right of way for non-highway related use, to include preparation of Right of Way Use Permits, which would require State review and approval.
- 1.2.13.3.6.** The Property Manager shall provide support to the State's District land acquisition and property management staff.

**1.2.14.** Vendor must provide Quality Assurance/Quality Control plan to be approved by the District upon award of Contract.

### **1.3. MILESTONES AND DELIVERABLES:**

- 1.3.1.** The Vendor shall be prepared to begin services immediately upon execution of the Contract.
- 1.3.2.** The Vendor shall meet with the District for an Introduction/Kickoff meeting as requested by the State.
- 1.3.3.** The State will identify the scope of services required, schedule (target dates), and milestones and deliverables at the time of the issuance of each Work Order. The District will provide the Work Order format that will be utilized, which may require use of the State's LAS system, in accordance with the current LAPPM.
- 1.3.4.** The selected Vendor will be expected to deliver all, or parts of the services outlined in this Section 1 as needed and as directed by the State on a Work Order basis.
- 1.3.5.** Completion Requirements for Work completed by Unit Prices
  - 1.3.5.1** The Appraisal Report, Review Appraisal Certification Report, Specialty Report, and any updated report of the same, shall be deemed complete when an acceptable report is submitted by the Vendor and approved by the State.

**1.3.5.2** The Negotiation, and an updated Negotiation, for a parcel will be deemed complete when the signed deed and all other documents, including subordinations, required to obtain title approval for the parcels are submitted by the Vendor and approved by the State’s District Land Acquisition Engineer/Manager.

If a parcel cannot reach a negotiated settlement, the Vendor upon the State’s request shall submit the completed documentation required to request eminent domain action. The Negotiation is deemed complete when the Complaint for Condemnation for the parcel is filed with the court.

Should additional information be required from the State or Office of the Attorney General for title approval, documentation or eminent domain action, the Vendor shall supply the requested information, which shall be deemed part of the original work order.

**1.3.5.3.** A Relocation, and a Relocation addendum, of a parcel shall be deemed complete when the parcel is vacated and able to be utilized for construction of the project, and the affected property owner(s) and/or displaced person(s) have received all payments for approved claims.

**1.4. VENDOR / STAFF SPECIFICATIONS:**

In the event that a dispute between Vendor and Subcontractor arises regarding payment for services performed or materials supplied under the Contract, the dispute resolution procedure outlined in Section 7(b) of the Illinois Prompt Payment Act, 30 ILCS 540/7(b) may be utilized by any aggrieved Subcontractor. Any payment or portion of a payment subject to this paragraph may only be withheld from a Subcontractor to which it is due for reasonable cause. Vendor shall not withhold retainage from a subcontractor. The State will not approve any delay or postponement of the 15 day payment requirement, above, except for reasonable cause shown after notice and hearing pursuant to Section 7(b) of the Illinois State Prompt Payment Act.

## 2. PRICING

### 2.1 FORMAT OF PRICING:

- 2.1.2 The estimated hours and number of units listed below are for evaluation purposes only **and not a guarantee or requirement of hours for any labor category.**
- 2.1.3 Method and Rate of Compensation: Offeror must complete the hourly rates and unit prices below in Tables A and B.
- 2.1.3.1. **FULLY LOADED HOURLY RATE (TABLE A):** Payment for actual hours worked at the rates for each item (henceforth known as HR). Fully Loaded Hourly Rates are submitted by the Vendor in the bid in Table A (Blue Columns) below and listed in the contract. Hourly rates are further defined in Section 1.2. for each category.
- 2.1.3.2. **UNIT PRICE:** Payment (rate) per unit **including profit.** Partial payments may be based on a completed amount subject to the total contract amount for the Offeror.

### 3. TERM AND TERMINATION

**3.1 TERM OF THIS CONTRACT:** This contract has an initial term of three (3) years. If a start date is not identified, the term shall commence upon the last dated signature of the Parties.

3.1.1 In no event will the total term of the contract, including the initial term, any renewal terms and any extensions, exceed ten (10) years. 30 ILCS 500/20-60

3.1.2 Vendor shall not commence billable work in furtherance of the contract prior to final execution of the contract except when permitted pursuant to 30 ILCS 500/20-80.

### 3.2 RENEWAL:

3.2.1. Any renewal is subject to the same terms and conditions as the original contract unless otherwise provided in the pricing section. The State may renew this contract for any or all of the option periods specified, may exercise any of the renewal options early, and may exercise more than one option at a time based on continuing need and favorable market conditions, when in the best interest of the State. The contract may neither renew automatically nor renew solely at the Vendor's option.

3.2.2. Pricing for the renewal term(s), or the formula for determining price, is shown in the pricing section of this contract.

3.2.3. The State reserves the right to renew for a total of 12 months in any one of the following manners:

3.2.3.1 One renewal covering the entire renewal allowance;

3.2.3.2 Individual one-year renewals up to and including the entire renewal allowance; or

3.2.3.3 Any combination of full or partial year renewals up to and including the entire renewal allowance.

**3.3 TERMINATION FOR CAUSE:** The State may terminate this contract, in whole or in part, immediately upon notice to the Vendor if: (a) the State determines that the actions or inactions of the Vendor, its agents, employees or subcontractors have caused, or reasonably could cause, jeopardy to health, safety, or property, or (b) the Vendor has notified the State that it is unable or unwilling to perform the contract.

If Vendor fails to perform to the State's satisfaction any material requirement of this contract, is in violation of a material provision of this contract, or the State determines that the Vendor lacks the financial resources to perform the contract, the State shall provide written notice to the Vendor to cure the problem identified within the period of time specified in the State's written notice. If not cured by that date the State may either: (a) immediately terminate the contract without additional written notice or (b) enforce the terms and conditions of the contract.

For termination due to any of the causes contained in this Section, the State retains its rights to seek any available legal or equitable remedies and damages.

- 3.4 TERMINATION FOR CONVENIENCE:** The State may, for its convenience and with thirty (30) days prior written notice to Vendor, terminate this contract in whole or in part and without payment of any penalty or incurring any further obligation to the Vendor.

Upon submission of invoices and proof of claim, the Vendor shall be entitled to compensation for supplies and services provided in compliance with this contract up to and including the date of termination.

- 3.5 AVAILABILITY OF APPROPRIATION:** This contract is contingent upon and subject to the availability of funds. The State, at its sole option, may terminate or suspend this contract, in whole or in part, without penalty or further payment being required, if (1) the Illinois General Assembly or the federal funding source fails to make an appropriation sufficient to pay such obligation, or if funds needed are insufficient for any reason (30 ILCS 500/20-60), (2) the Governor decreases the Agency's funding by reserving some or all of the Agency's appropriation(s) pursuant to power delegated to the Governor by the Illinois General Assembly, or (3) the Agency determines, in its sole discretion or as directed by the Office of the Governor, that a reduction is necessary or advisable based upon actual or projected budgetary considerations. Contractor will be notified in writing of the failure of appropriation or of a reduction or decrease.

## 4. STANDARD BUSINESS TERMS AND CONDITIONS

### 4.1 PAYMENT TERMS AND CONDITIONS:

- 4.1.1 **Late Payment:** Payments, including late payment charges, will be paid in accordance with the State Prompt Payment Act and rules when applicable. 30 ILCS 540; 74 Ill. Adm. Code 900. This shall be Vendor's sole remedy for late payments by the State. Payment terms contained in Vendor's invoices shall have no force or effect.
- 4.1.2 **Minority Contractor Initiative:** Any Vendor awarded a contract of \$1,000 or more under Section 20-10, 20-15, 20-25 or 20-30 of the Illinois Procurement Code (30 ILCS 500) is required to pay a fee of \$15. The Comptroller shall deduct the fee from the first check issued to the Vendor under the contract and deposit the fee in the Comptroller's Administrative Fund. 15 ILCS 405/23.9.
- 4.1.3 **Vendor Assurance:** The Vendor makes the following assurance and this assurance must be included in each subcontract that the Vendor signs with a subcontractor or supplier. The Vendor, sub-recipient or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in performance of this contract. The Vendor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the Vendor to carry out these requirements is a material breach of this contract, which may result in termination of this contract or such other remedy, as the Department deems appropriate, which may include, but not limited to:
- 4.1.3.1 Withholding payments;
  - 4.1.3.2 Assessing Sanctions;
  - 4.1.3.3 Liquidated Damages; and/or
  - 4.1.3.4 Disqualifying the Vendor from future contracting as non-responsible.
- 4.1.4 **Expenses:** The State will not pay for supplies provided or services rendered, including related expenses, incurred prior to the execution of this contract by the Parties even if the effective date of the contract is prior to execution.
- 4.1.5 **Prevailing Wage:** As a condition of receiving payment Vendor must (i) be in compliance with the contract, (ii) pay its employees prevailing wages when required by law, (iii) pay its suppliers and subcontractors according to the terms of their respective contracts, and (iv) provide lien waivers to the State upon request. Examples of prevailing wage categories include public works, printing, janitorial, window washing, building and grounds services, site technician services, natural resource services, security guard and food services. The prevailing wages are revised by the Illinois Department of Labor (DOL) and are available on DOL's official website, which shall be deemed proper notification of

any rate changes under this subsection. Vendor is responsible for contacting DOL at 217-782-6206 or (<https://www2.illinois.gov/idol/Pages/default.aspx>) to ensure understanding of prevailing wage requirements.

4.1.6 **Federal Funding:** This contract may be partially or totally funded with Federal funds. If Federal funds are expected to be used, then the percentage of the good/service paid using Federal funds and the total Federal funds expected to be used will be provided to the awarded Vendor in the notice of intent to award.

4.1.7 **Invoicing:** By submitting an invoice, Vendor certifies that the supplies or services provided meet all requirements of this contract, and the amount billed and expenses incurred are as allowed in this contract. Invoices for supplies purchased, services performed, and expenses incurred through June 30 of any year must be submitted to the State no later than July 31 of that year; otherwise Vendor may have to seek payment through the Illinois Court of Claims. 30 ILCS 105/25. All invoices are subject to statutory offset. 30 ILCS 210.

4.1.7.1 Vendor shall not bill for any taxes unless accompanied by proof that the State is subject to the tax. If necessary, Vendor may request the applicable Agency’s Illinois tax exemption number and Federal tax exemption information.

4.1.7.2 Vendor shall invoice at this completion of the contract unless invoicing is tied in this contract to milestones, deliverables, or other invoicing requirements agreed to in the contract.

#### **4.2 SETTLEMENT OF CONSULTANT CLAIMS:**

4.2.1 In any case where the Vendor deems that additional compensation will be due them for services or materials not covered in the Contract nor ordered in writing by the Department, the Vendor shall notify the Department in writing before they begin the additional services for which they proposes to base the claim. If such notification is not previously given or claimed costs are not clearly identified and separated in their accounting records, the Vendor agrees to waive the claim for such additional compensation. However, such notice or accounting by the Vendor shall not in any way be construed as proving the validity of their claim.

4.2.2 Any dispute in the interpretation of the provisions of the Contract shall be settled through negotiation between the liaison managers of the signatory parties. If they cannot agree, the dispute will be referred through proper administrative channels to the Department. The Department shall decide all claims, questions and disputes and the decision shall be final. This shall not be construed to abrogate the Vendor's rights under the law.

4.2.3 The titles and captions to all sections of these Standard Terms and Conditions are intended for convenience of reference only and shall not be construed as having any pertinence to the interpretation of the content of the sections which they introduce.

**4.3 ASSIGNMENT:** This contract may not be assigned or transferred in whole or in part by Vendor without the prior written consent of the State.

**4.4 SUBCONTRACTING:** For purposes of this section, subcontractors are those specifically hired to perform all or part of the work covered by this contract. Vendor must receive prior written approval before use of any subcontractors in the performance of this contract. Vendor shall describe, in an attachment if not already provided, the names and addresses of all authorized subcontractors to be utilized by Vendor in the performance of this contract, together with a description of the work to be performed by the subcontractor and the anticipated amount of money that each subcontractor is expected to receive pursuant to this contract. If required, Vendor shall provide a copy of any subcontracts within fifteen (15) days after execution of this contract. All subcontracts must include the same certifications that Vendor must make as a condition of this contract. Vendor shall include in each subcontract the subcontractor certifications as shown on the Standard Certification form available from the State. If at any time during the term of the Contract, Vendor adds or changes any subcontractors, then Vendor must promptly notify, by written amendment to the Contract, the State Purchasing Officer or the Chief Procurement Officer of the names and addresses and the expected amount of money that each new or replaced subcontractor will receive pursuant to the Contract. 30 ILCS 500/20-120.

**4.5 AUDIT/RETENTION OF RECORDS:** Vendor and its subcontractors shall maintain books and records relating to the performance of this contract and any subcontract necessary to support amounts charged to the State pursuant this contract or subcontract. Books and records, including information stored in databases or other computer systems, shall be maintained by the Vendor for a period of three (3) years from the later of the date of

final payment under the contract or completion of the contract, and by the subcontractor for a period of three (3) years from the later of final payment under the term or completion of the subcontract. If Federal funds are used to pay contract costs, the Vendor and its subcontractors must retain their respective records for five (5) years. Books and records required to be maintained under this section shall be available for review or audit by representatives of: the procuring Agency, the Auditor General, the Executive Inspector General, the Chief Procurement Officer, State of Illinois internal auditors or other governmental entities with monitoring authority, upon reasonable notice and during normal business hours. Vendor and its subcontractors shall cooperate fully with any such audit and with any investigation conducted by any of these entities. Failure to maintain books and records required by this section shall establish a presumption in favor of the State for the recovery of any funds paid by the State under this contract or any subcontract for which adequate books and records are not available to support the purported disbursement. The Vendor or subcontractors shall not impose a charge for audit or examination of the Vendor's or subcontractor's books and records. 30 ILCS 500/20-65.

- 4.6 TIME IS OF THE ESSENCE:** Time is of the essence with respect to Vendor's performance of this contract. Vendor shall continue to perform its obligations while any dispute concerning this contract is being resolved unless otherwise directed by the State.
- 4.7 NO WAIVER OF RIGHTS:** Except as specifically waived in writing, failure by a Party to exercise or enforce a right does not waive that Party's right to exercise or enforce that or other rights in the future.
- 4.8 FORCE MAJEURE:** Failure by either Party to perform its duties and obligations will be excused by unforeseeable circumstances beyond its reasonable control and not due to its negligence, including acts of nature, acts of terrorism, riots, labor disputes, fire, flood, explosion, and governmental prohibition. The non-declaring Party may cancel this contract without penalty if performance does not resume within thirty (30) days of the declaration.
- 4.9 CONFIDENTIAL INFORMATION:** Each Party to this contract, including its agents and subcontractors, may have or gain access to confidential data or information owned or maintained by the other Party in the course of carrying out its responsibilities under this contract. Vendor shall presume all information received from the State or to which it gains access pursuant to this contract is confidential. Vendor information, unless clearly marked as confidential and exempt from disclosure under the Illinois Freedom of Information Act, shall be considered public. No confidential data collected, maintained, or used in the course of performance of this contract shall be disseminated except as authorized by law and with the written consent of the disclosing Party, either during the period of this contract or thereafter. The receiving Party must return any and all data collected, maintained, created or used in the course of the performance of this contract, in whatever form it is maintained, promptly at the end of this contract, or earlier at the request of the disclosing Party, or notify the disclosing Party in writing of its destruction.

The foregoing obligations shall not apply to confidential data or information lawfully in the receiving Party's possession prior to its acquisition from the disclosing Party; received in good faith from a third Party not subject to any confidentiality obligation to the disclosing Party; now is or later becomes publicly known through no breach of confidentiality obligation by the receiving Party; or that is independently developed by the receiving Party without the use or benefit of the disclosing Party's confidential information.

**4.10 USE AND OWNERSHIP:** All work performed or supplies created by Vendor under this contract, whether written documents or data, goods or deliverables of any kind, shall be deemed work for hire under copyright law and all intellectual property and other laws, and the State of Illinois is granted sole and exclusive ownership to all such work, unless otherwise agreed in writing. Vendor hereby assigns to the State all right, title, and interest in and to such work including any related intellectual property rights, and/or waives any and all claims that Vendor may have to such work including any so-called "moral rights" in connection with the work. Vendor acknowledges the State may use the work product for any purpose. Confidential data or information contained in such work shall be subject to the confidentiality provisions of this contract.

**4.11 INDEMNIFICATION AND LIABILITY:** The Vendor shall indemnify and hold harmless the State of Illinois, its agencies, officers, employees, agents and volunteers from any and all costs, demands, expenses, losses, claims, damages, liabilities, settlements and judgments, including in-house and contracted attorneys' fees and expenses, arising out of: (a) any breach or violation by Vendor of any of its certifications, representations, warranties, covenants or agreements; (b) any actual or alleged death or injury to any person, damage to any real or personal property, or any other damage or loss claimed to result in whole or in part from Vendor's negligent performance; (c) any act, activity or omission of Vendor or any of its employees, representatives, subcontractors or agents; or (d) any actual or alleged claim that the services or goods provided under this contract infringe, misappropriate, or otherwise violate any intellectual property (patent, copyright, trade secret, or trademark) rights of a third party. In accordance with Article VIII, Section 1(a), (b) of the Constitution of the State of Illinois and 1973 Illinois Attorney General Opinion 78, the State may not indemnify private parties absent express statutory authority permitting the indemnification. Neither Party shall be liable for incidental, special, consequential, or punitive damages.

**4.12 INSURANCE:** Vendor shall, at all times during the term of this contract and any renewals or extensions, maintain and provide a Certificate of Insurance naming the State as an additionally insured for all required bonds and insurance. Certificates may not be modified or canceled until at least thirty (30) days' notice has been provided to the State. Vendor shall provide: (a) General Commercial Liability insurance in the amount of \$1,000,000 per occurrence (Combined Single Limit Bodily Injury and Property Damage) and \$2,000,000 Annual Aggregate; (b) Auto Liability, including Hired Auto and Non-owned

Auto (Combined Single Limit Bodily Injury and Property Damage), in amount of \$1,000,000 per occurrence; and (c) Worker's Compensation Insurance in the amount required by law. Insurance shall not limit Vendor's obligation to indemnify, defend, or settle any claims.

**4.13 INDEPENDENT CONTRACTOR:** Vendor shall act as an independent contractor and not an agent or employee of, or joint venture with the State. All payments by the State shall be made on that basis.

**4.14 SOLICITATION AND EMPLOYMENT:** Vendor shall not employ any person employed by the State during the term of this contract to perform any work under this contract. Vendor shall give notice immediately to the Agency's director if Vendor solicits or intends to solicit State employees to perform any work under this contract.

**4.15 COMPLIANCE WITH THE LAW:** The Vendor, its employees, agents, and subcontractors shall comply with all applicable Federal, State, and local laws, rules, ordinances, regulations, orders, Federal circulars and all license and permit requirements in the performance of this contract. Vendor shall be in compliance with applicable tax requirements and shall be current in payment of such taxes. Vendor shall obtain at its own expense, all licenses and permissions necessary for the performance of this contract.

**4.16 BACKGROUND CHECK:** Whenever the State deems it reasonably necessary for security reasons, the State may conduct, at its expense, criminal and driver history background checks of Vendor's and subcontractor's officers, employees or agents. Vendor or subcontractor shall immediately reassign any individual who, in the opinion of the State, does not pass the background check.

**4.17 APPLICABLE LAW:**

4.17.1 **PREVAILING LAW:** This contract shall be construed in accordance with and is subject to the laws and rules of the State of Illinois.

4.17.2 **EQUAL OPPORTUNITY:** The Department of Human Rights' Equal Opportunity requirements are incorporated by reference. 44 ILL. ADM. CODE 750.

4.17.3 **COURT OF CLAIMS; ARBITRATION; SOVEREIGN IMMUNITY:** Any claim against the State arising out of this contract must be filed exclusively with the Illinois Court of Claims. 705 ILCS 505/1. The State shall not enter into binding arbitration to resolve any dispute arising out of this contract. The State of Illinois does not waive sovereign immunity by entering into this contract.

4.17.4 **OFFICIAL TEXT:** The official text of the statutes cited herein is incorporated by reference. An unofficial version can be viewed at ([www.ilga.gov/legislation/ilcs/ilcs.asp](http://www.ilga.gov/legislation/ilcs/ilcs.asp)).

**4.18 ANTI-TRUST ASSIGNMENT:** If Vendor does not pursue any claim or cause of action it has arising under Federal or State antitrust laws relating to the subject matter of this contract,

then upon request of the Illinois Attorney General, Vendor shall assign to the State all of Vendor's rights, title and interest to the claim or cause of action.

- 4.19 CONTRACTUAL AUTHORITY:** The Agency that signs this contract on behalf of the State of Illinois shall be the only State entity responsible for performance and payment under this contract. When the Chief Procurement Officer or authorized designee or State Purchasing Officer signs in addition to an Agency, he/she does so as approving officer and shall have no liability to Vendor.
- 4.20 NOTICES:** Notices and other communications provided for herein shall be given in writing via electronic mail whenever possible. If transmission via electronic mail is not possible, then notices and other communications shall be given in writing via registered or certified mail with return receipt requested, via receipted hand delivery, via courier (UPS, Federal Express or other similar and reliable carrier), or via facsimile showing the date and time of successful receipt. Notices shall be sent to the individuals who signed this contract using the contact information following the signatures. Each such notice shall be deemed to have been provided at the time it is actually received. By giving notice, either Party may change its contact information.
- 4.21 MODIFICATIONS AND SURVIVAL:** Amendments, modifications and waivers must be in writing and signed by authorized representatives of the Parties. Any provision of this contract officially declared void, unenforceable, or against public policy, shall be ignored and the remaining provisions shall be interpreted, as far as possible, to give effect to the Parties' intent. All provisions that by their nature would be expected to survive, shall survive termination. In the event of a conflict between the State's and the Vendor's terms, conditions and attachments, the State's terms, conditions and attachments shall prevail.
- 4.22 PERFORMANCE RECORD / SUSPENSION:** Upon request of the State, Vendor shall meet to discuss performance or provide contract performance updates to help ensure proper performance of this contract. The State may consider Vendor's performance under this contract and compliance with law and rule to determine whether to continue this contract, suspend Vendor from doing future business with the State for a specified period of time, or whether Vendor can be considered responsible on specific future contract opportunities.
- 4.23 FREEDOM OF INFORMATION ACT:** This contract and all related public records maintained by, provided to, or required to be provided to the State are subject to the Illinois Freedom of Information Act (FOIA) notwithstanding any provision to the contrary that may be found in this contract. 5 ILCS 140.
- 4.24 SCHEDULE OF WORK:** Any work performed on State premises shall be performed during the hours designated by the State and performed in a manner that does not interfere with the State and its personnel.

#### **4.25 WARRANTIES FOR SUPPLIES AND SERVICES:**

4.25.1. Vendor warrants that the supplies furnished under this contract will: (a) conform to the standards, specifications, drawing, samples or descriptions furnished by the State or furnished by the Vendor and agreed to by the State, including but not limited to all specifications attached as exhibits hereto; (b) be merchantable, of good quality and workmanship, and free from defects for a period of twelve months or longer if so specified in writing, and fit and sufficient for the intended use; (c) comply with all federal and state laws, regulations and ordinances pertaining to the manufacturing, packing, labeling, sale and delivery of the supplies; (d) be of good title and be free and clear of all liens and encumbrances and; (e) not infringe any patent, copyright or other intellectual property rights of any third party. Vendor agrees to reimburse the State for any losses, costs, damages or expenses, including without limitations, reasonable attorney's fees and expenses, arising from failure of the supplies to meet such warranties.

4.25.2. Vendor shall ensure that all manufacturers' warranties are transferred to the State and shall provide to the State copies of such warranties. These warranties shall be in addition to all other warranties, express, implied or statutory, and shall survive the State's payment, acceptance, inspection or failure to inspect the supplies.

4.25.3. Vendor warrants that all services will be performed to meet the requirements of this contract in an efficient and effective manner by trained and competent personnel. Vendor shall monitor performances of each individual and shall immediately reassign any individual who does not perform in accordance with this contract, who is disruptive or not respectful of others in the workplace, or who in any way violates the contract or State policies.

Acceptance of the services will not relieve the Vendor of the responsibility for subsequent correction or of his/her liability for loss or damage resulting therefrom. In the event any dispute should arise between any of the parties to this Contract, each party agrees to exercise good faith efforts to resolve the matter fairly, amicably and in a timely manner.

#### **4.26 REPORTING, STATUS AND MONITORING SPECIFICATIONS:**

4.26.1 Vendor shall immediately notify the State of any event that may have a material impact on Vendor's ability to perform this contract.

4.26.2 If applicable, by August 31 of each year, Vendor shall report to the Agency the number of qualified veterans and certain ex-offenders hired during Vendor's last completed fiscal year. For the purposes of this section, qualified veteran is defined in 30 ILCS 500/45-67 and ex-offender is defined in 30 ILCS 500/45-70.

- 4.27 EMPLOYMENT TAX CREDIT:** Vendors who hire qualified veterans and certain offenders may be eligible for tax credits. 35 ILCS 5/216, 5/217. Please contact the Illinois Department of Revenue (telephone #: 217-524-4772) for information about tax credits.

- 5.1.8. **VENDOR** - The individual or Vendor providing land acquisition services as a party to the contract.
- 5.1.9. **CONTRACT** - The written contract between the State and the Vendor setting forth the obligations of the parties, including, but not limited to, the performance of the services, the furnishing of labor and materials, and the basis of payment. Includes all Addendums.

- 5.1.15. **ERROR** - A failure to provide professional services in accordance with that degree of care and skill ordinarily exercised under similar conditions excluding, however, omissions.
- 5.1.16. **FHWA** - The Federal Highway Administration of the United States State of Transportation (DOT).



- 5.1.17. **IFB – INVITATION FOR BID** – the process by which a purchasing agency requests information from bidders, including all documents, whether attached or incorporated by reference, used for soliciting bids
- 5.1.18. **KEY PERSONNEL** - The Vendor’s personnel specified in the bid and in the contract, who are considered essential to the services being performed.
- 5.1.19. **LAND ACQUISITION SYSTEM (LAS)** – The State’s system used to track parcel information and request payment for the acquisition of property needed for a highway project.
- 5.1.20. **NEGLIGENCE** - The omission or neglect of reasonable precaution, care or action in accordance with that degree of care and skill ordinarily exercised under similar conditions.
- 5.1.21. **OMISSION** - A failure to provide professional services in accordance with that degree of care and skill ordinarily exercised under similar conditions whereby there is a failure to indicate on reports or other products of professional services the requirement for a feature, system or equipment, which is necessary to the complete function of a project.
- 5.1.22. **PROGRESS REPORT** - A written report to the District land acquisition engineer/manager indicating the status of the critical milestones set up in the work orders. The schedule for submittal of the report will be determined in the work orders.
- 5.1.23. **PROJECT** - The proposed highway improvement within the District that is the subject of the services stipulated in the contract.
- 5.1.24. **PROJECT KICKOFF MEETING** - Meeting to be held at the District office for the purposes of introductions of the State and Vendor staff and Subcontractors to discuss the scope and schedule of the project, and to answer questions of any of the parties.
- 5.1.25. **PROJECT MANAGER** - The duly authorized representatives of the Vendor charged with the day-to-day administration of the terms of the contract
- 5.1.26. **PROJECT SCHEDULE** - A comprehensive description of all significant services required of the Vendor and of all actions required of the State and Approving Parties by the obligations of the contract, together with the durations and/or dates for performing these services and actions.
- 5.1.27. **PROJECT STATUS MEETING** - Meeting between the Vendor’s project manager, possibly other Vendor staff and District land acquisition personnel to discuss status of project in general and including any specific issues affecting the Vendor’s ability to meet the milestones.
- 5.1.28. **PROJECT TIMELINE** - A timeline provided by the project manager of all acquisition activities required to meet the project’s given deadline including the critical milestones dates and the names of the staff and subcontractors that will be used.
- 5.1.29. **QUALITY ASSURANCE** - All those planned and systematic actions to provide adequate confidence that a structure, system, or component will perform satisfactorily in service.
- 5.1.30. **QUALITY CONTROL** - A system for maintaining desired standards in a product or process, especially by inspecting samples of the product.
- 5.1.31. **RECORD DOCUMENTS** - The documents, signed and/or sealed by a person, duly licensed or registered in the appropriate category by the State of Professional Regulation of the State of Illinois, will be the Documents of Record for the project. Documents reproduced by any method shall not supersede the Document of Record.

- 5.1.32. **REGIONAL ENGINEER** - The Individual of the State who has jurisdiction over the services within a District.
- 5.1.33. **SCOPE OF SERVICES** - All services and actions required of the Vendor by the obligations of the contract.
- 5.1.34. **SERVICES** - Services provided by a Vendor or on their behalf in the performance of reports, assessments, cost estimates, evaluations, consultations, inspections, scheduling, sequencing, training, appraisals, review appraisals, negotiation documents, relocation documents.
- 5.1.35. **SUBCONTRACTOR** - Any independent professional Vendor, person or organization who, with the approval of the State, performs a part of the services for the Vendor.
- 5.1.36. **WORK ORDER** - Authorization by the State to the Vendor to proceed with the services for each separate job issued under the contract.

5.2.1. **AGENTS AND EMPLOYEES:** Vendor shall be responsible for the negligent acts and omissions of its agents, employees and subcontractors in their performance of Vendor's duties under this Contract. Vendor represents that it shall utilize the services of individuals skilled in the profession for which they will be used in performing services hereunder. In the event that the Agency/Buyer determines that any individual performing services for Vendor hereunder is not providing such skilled services, it shall promptly so notify Vendor and Vendor shall replace that individual.

5.2.2. **PUBLICITY:** Vendor shall not, in any advertisement or any other type of solicitation for business, state, indicate or otherwise imply that it is under contract to the Agency/Buyer nor shall the Agency/Buyer's name be used in any such advertisement or solicitation without prior written approval except as required by law.

- 5.2.4. - 5.2.6. SUCCESSORS IN INTEREST:** All the terms, provisions, and conditions of the Contract shall be binding upon and inure to the benefit of the parties hereto and their respective successors, assigns and legal representatives.
- 5.2.7. VENDOR'S TERMINATION DUTIES:** The Vendor, upon receipt of notice of termination or upon request of the Agency/Buyer, shall:
- 5.2.7.1.** Cease work under this Contract and take all necessary or appropriate steps to limit disbursements and minimize costs, and furnish a report within thirty (30) days of the date of notice of termination, describing the status of all work under the Contract, including, without limitation, results accomplished, conclusions resulting therefrom, any other matters the Agency/Buyer may require;
  - 5.2.7.2.** Immediately cease using and return to the Agency/Buyer any personal property or materials, whether tangible or intangible, provided by the Agency/Buyer to the Vendor;
  - 5.2.7.3.** Comply with the Agency/Buyer's instructions for the timely transfer of any active files and work product produced by the Vendor under this Contract;
  - 5.2.7.4.** Cooperate in good faith with the Agency/Buyer, its employees, agents and contractors during the transition period between the notification of termination and the substitution of any replacement contractor; and
  - 5.2.7.5.** Immediately return to the Agency/Buyer any payments made by the Agency/Buyer for services that were not rendered by the Vendor.
- 5.2.8. OVERTIME:** Any overtime costs shall be incurred by the vendor.

- 5.2.9. USE OF WORK PRODUCT:** Unless otherwise agreed in writing, the following applies regarding work product created or produced under this Contract:
- 5.2.9.1.** Work product produced under this Contract, including, but not limited to, documents, reports, information, documentation of any sort and ideas, whether preliminary or final, shall become and remain the property of the State and/or Agency/Buyer, including any patent, copyright or other intellectual property rights;
  - 5.2.9.2.** With the exception of ideas, all such work products shall be considered works made for hire within the meaning of 17 U.S.C. § 101;
  - 5.2.9.3.** To the extent that any portion of such work product is not a work made for hire, Vendor completely and without reservation assigns to the Agency/Buyer all right, title and interest in and to such portion of the work product, as well as all related intellectual property rights, including patent and copyright;
  - 5.2.9.4.** Agency/Buyer shall exercise all rights of ownership in all such work product without restriction or limitation, without further compensation to Vendor.
  - 5.2.9.5.** Vendor shall not acquire or have any right to use, disclose or reproduce the work product or any equipment, documents, information, media, software, or know-how obtained from the State except to perform this Contract. Nothing herein shall be construed as precluding the use of any information independently acquired by Vendor without such limitation;
  - 5.2.9.6.** The ideas, methodologies, processes, inventions and tools (including computer hardware and software where applicable) that Vendor previously developed and brings to the Agency/Buyer in furtherance of performance of the Contract shall remain the property of the Vendor; and;
  - 5.2.9.7.** Vendor grants to the Agency/Buyer a nonexclusive license to use and employ such software, ideas, concepts, methodologies, processes, inventions and tools solely within its enterprise.
- 5.2.10 EXPATRIATED ENTITIES:** Except in limited circumstances, no business or member of a unitary business group, as defined in the Illinois Income Tax Act, shall submit a bid for or enter into a contract with a State agency if that business or any member of the unitary business group is an expatriated entity.
- 5.2.11. EMPLOYMENT SECURITY:** Section 20 ILCS 1005/1005-47 of the Civil Administrative Code of Illinois states that the Department of Employment Security maintains the Illinois Job Link web site <https://illinoisjoblink.illinois.gov/ada/r/> which allows job seekers to search online for employment opportunities that match the skills of the person seeking employment. Any entity that is a party to a contract with an executive branch State agency is required to post employment vacancies on the web site or provide an online link to its employment vacancies so that it is accessible through the web site. Bidders that are a party to a contract with a bona fide labor organization are exempt from this requirement.

**5.2.12. AMENDMENTS:** This Contract may be amended in writing from time to time by mutual consent of the parties. All amendments to this Contract shall be in writing and fully executed by the parties.

**5.2.13. PURCHASE OF EQUIPMENT AND MAINTENANCE ASSURANCE:** Vendor shall not purchase equipment with funds received under this Contract without having obtained the Agency/Buyer's prior approval. For purposes of this Article, "equipment" shall include any product, tangible and non-tangible, used solely in Vendor's performance under this Contract and having a useful life of two years or more and an acquisition cost of at least \$100. Vendor acknowledges that the Agency/Buyer is under no obligation to give consent and that the Agency/Buyer may, if it gives consent, subject that consent to such additional terms and conditions as the Agency/Buyer may require. Vendor acknowledges that any equipment purchased under this provision is and shall remain the property of the Agency/Buyer.

The Agency/Buyer reserves the right to maintain any equipment purchased under this Contract using Agency/Buyer personnel or third-party maintainers. In such case, Vendor shall provide the Agency/Buyer or its maintenance provider with such services, documentation, materials and parts under reasonable terms and conditions and at reasonable costs. The Agency/Buyer reserves the right to return to Vendor's maintenance following written certification by Vendor that the equipment is eligible for Vendor's maintenance. Vendor's standard charges for the certification inspection, plus any applicable charges required to bring the equipment into eligibility for Vendor's maintenance shall apply. Exercise of these rights by the Agency/Buyer shall be without penalty or sanction by Vendor.

If Vendor discontinues service or maintenance of equipment or software provided under this Contract, Vendor shall provide to the Agency/Buyer at no cost adequate documentation and access to specialized or proprietary tools to allow the Agency/Buyer or a subcontractor to maintain the equipment or software. This provision shall not apply if Vendor arranges for continued service and maintenance through another Vendor and at a price acceptable to the Agency/Buyer.

**5.2.14. USE OF THIRD PARTIES:** The Agency/Buyer acknowledges that the Vendor may contract with third parties for the performance of any of the Vendor's obligations under this Contract. However, all subcontracts shall be subject to prior approval by the Agency/Buyer, so the Vendor shall obtain the Agency/Buyer's prior written consent before allowing any Third Party to perform any of the Vendor's obligations under this Contract.

A Vendor who obtains the Agency/Buyer's prior written consent and subsequently enters into a contract with a Third Party for performance of any of the Vendor's obligations under this Contract remains responsible for all services performed under this Contract. All restrictions, obligations and responsibilities of the Vendor under this Contract shall also apply fully and completely to subcontractors. This includes requiring all subcontractors to submit certifications and disclosures to Agency/Buyer for review and approval upon request. The Agency/Buyer shall have the right to request the removal of a subcontractor from the Contract for good cause.

### 5.3. ADDITIONAL AGENCY SPECIFIC TERMS

#### 5.3.1. SAFETY GEAR (Headgear, Vest, and footwear Policy)

- 5.3.1.1. All employees of a Vendor engaged in ground level field activities on or within 8 meters (25 feet) of a pavement open to traffic, shall wear high visibility vests or approved high visibility outer garments. Flaggers shall wear high visibility vests at all times.
- 5.3.1.2. All employees of a Vendor are required to wear either hardhats or caps of high visibility color when engaged in field activities within 8 meters (25 feet) of a pavement open to traffic or under construction, when not in vehicles or self-propelled mobile equipment.
- 5.3.1.3. All employees of a Vendor are required to wear protective hardhats/caps when they are in an area where there is a potential for injury from falling, moving, swinging or flying objects.
- 5.3.1.4. Safety-toe footwear shall be worn by employees of a Vendor engaged in operations where the danger of injury to the foot may occur. All employees of a Vendor should also wear appropriate clothing for the work task involved. This includes shirts when in the vicinity of the public.

**5.3.2. RIGHT TO ENTER** - In accordance with Department practices, the Vendor will notify all property owners of intent to enter for land acquisition services and will furnish a detailed record of all such contacts to the Department on a monthly basis. If owners cannot be found, the occupant will be notified. The State will supply requested documents identifying the Vendor as the Department's agent. If the property owner or occupant denies the Vendor permission to enter or if neither can be found, such incident will be reported to the Department. The Department will initiate necessary procedures after receipt of such report.



**Contract Goal to be achieved by the Vendor:** This solicitation includes a specific DBE utilization goal of **10%** based on the availability of certified Vendors to perform or provide the anticipated services and/or supplies required by this solicitation. In addition to the other award criteria established for this solicitation, the Department will award this contract to a Vendor that meets the goal or makes good faith efforts to meet the goal. This goal is also applicable to change orders and allowances within the scope of work provided by the certified Vendor.

Following are guidelines for the Vendor's response to the Participation and Utilization Plan. Attached at Section 7.11 are the **BoBS Procurement DBE Utilization Plan (BoBs 2574)** and **BoBS Procurement DBE Participation Statement (BoBS 2575)** to be completed by the Vendor. Vendor should include any additional information that will add clarity to the Vendor's proposed utilization of DBEs to meet the contract goal. Failure to cooperate may render the bid or proposal non-responsive. The contract will not be finally awarded until the Vendor's Utilization Plan is approved.
4. **Vendor Assurance:** The Vendor makes the following assurance and this assurance must be included

in each subcontract that the Vendor signs with a subcontractor or supplier. The Vendor, sub-recipient or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The Vendor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of contracts funded in whole or in part with federal or state funds. Failure by the Vendor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy, as the Department deems appropriate, which may include, but is not limited to:

- (a) Withholding payments;
- (b) Assessing sanctions;
- (c) Liquidated damages; and/or

5.1. The value of the work actually performed by the DBE's forces shall be counted towards the goal. The entire amount of that portion of the contract that is performed by the DBE's forces, including supplies purchased or equipment leased by the DBE shall be counted, except supplies purchased and equipment rented from the Vendor.

5.2. Count the entire amount of fees or commissions charged by a DBE firm for providing a bona fide service, such as professional, technical, consultant, or managerial services, or for providing bonds or insurance specifically required for the performance of a DOT-assisted contract, toward DBE goals, provided IDOT determines the fee to be reasonable and not excessive as compared with fees customarily allowed for similar services.

5.3. A joint venture shall count the portion of the total dollar value of the contract equal to the distinct, clearly defined portion of the work of the contract that the DBE performs with its forces toward the goal. A joint venture shall also count the dollar value of work subcontracted to other DBEs. Work performed by the forces of a non-DBE joint venture partner shall not be counted toward the goal.

5.4. When a DBE subcontracts part of the work of its contract to another firm, the value of the subcontracted work shall be counted toward the contract goal only if the DBE's subcontractor is a DBE. Work that a DBE subcontracts to a non-DBE will not count towards the goal.

5.5. If applicable, A Vendor shall count towards the goal 60 percent of its expenditures for materials and supplies required under the contract and obtained from a DBE manufacturer, regular dealer or supplier.

5.6. A Vendor shall count towards the goal only expenditures to DBEs that perform a commercially useful function in the work of the contract as defined in 49 CFR 26.55(c).

5.6.1. A DBE performs a commercially useful function when it is responsible for execution of the work of the contract and is carrying out its responsibilities by actually performing, managing,

and supervising the work involved. To perform a commercially useful function, the DBE must also be responsible, with respect to materials or supplies used on the contract, for negotiating price, determining quality and quantity, ordering the materials or supplies, and installing the materials (where applicable) and paying for the material or supplies. To determine whether a firm is performing a commercially useful function, the Department shall evaluate the amount of work subcontracted, whether the amount the firm is to be paid under the contract is commensurate with the work it is actually performing, and the credit claimed for its performance of the work, industry practices, and other relevant factors.

5.6.2. A DBE does not perform a commercially useful function if its role is limited to that of an extra participant in a transaction, contract, or project through which funds are passed to obtain the appearance of DBE participation. In determining whether a DBE is such an extra participant, the Department shall examine similar transactions, particularly those in which DBEs do not participate.

5.7. A Vendor shall not count towards the goal expenditures that are not direct, necessary and proximately related to the work of the contract. Only the amount of services or goods that are directly attributable to the performance of the contract shall be counted. Ineligible expenditures include general office overhead or other Vendor support activities.

6. **Good Faith Effort Procedures:** If the Vendor cannot meet the goal, the Vendor must document in the Utilization Plan its good faith efforts that could reasonably have been expected to meet the goal. Vendors must submit utilization forms that meet or exceed the published goal or submit utilization forms that describe a percentage participation that is less than the goal and submit documentation regarding good faith efforts at the time of bid or proposal submission. The Department will consider the quality, quantity, and intensity of the Vendor's efforts. Mere *pro forma* efforts, in other words, efforts done as a matter of form, are not good faith efforts; rather, the Vendor is expected to have taken genuine efforts that would be reasonably expected of a Vendor actively and aggressively trying to obtain DBE participation sufficient to meet the contract goal.

6.1. The following is a list of types of action that the Department will consider as evidence of the Vendor's good faith efforts to meet the goal. These listed factors are not intended to be a mandatory checklist and are not intended to be exhaustive. Other factors or efforts brought to the attention of the Department may be relevant in appropriate cases, and will be considered by the Department

6.1.1. Soliciting through all reasonable and available means (e.g., attendance at pre-bid meetings, advertising and/or written notices) the interest of all certified Vendors that have the capability to perform the work of the contract. The Vendor must solicit this interest within sufficient time to allow the certified Vendors to respond to the solicitation. The Vendor must determine with certainty if the DBEs are interested by taking appropriate steps to follow up initial solicitations and encourage them to bid or submit offers. The Vendor must provide interested certified Vendors with adequate information about the plans, specifications, and requirements of the contract in a

timely manner to assist them in responding promptly to the solicitation.

- 6.1.2. Selecting portions of the work to be performed by certified Vendors in order to increase the likelihood that the DBE goal will be achieved. This includes, where appropriate, breaking out contract work items into economically feasible units to facilitate certified Vendor participation, even when the Vendor might otherwise prefer to perform these work items with its own forces.
- 6.1.3. Making a portion of the work available to DBEs and selecting those portions of the work or material needs consistent with their availability, so as to facilitate DBE participation.
- 6.1.4. Negotiating in good faith with interested DBEs. It is the Vendor's responsibility to make a portion of the work available to DBE subcontractors and suppliers and to select those portions of the work or material needs consistent with the available DBE subcontractors and suppliers, so as to facilitate DBE participation. Evidence of such negotiation includes the names, addresses, and telephone numbers of DBEs that were considered; a description of the information provided regarding the plans, specifications, and requirements for the work selected for subcontracting and evidence as to why additional agreements could not be reached for DBEs to perform the work. A Vendor using good business judgment will consider a number of factors in negotiating with DBEs and will take a firm's price and capabilities as well as contract goals into consideration. The fact that there may be some additional costs involved in finding and using DBEs is not in itself sufficient reason for a Vendor's failure to meet the DBE goal, as long as such costs are reasonable. Also, the ability or desire of a Vendor to perform the work of a contract with its own organization does not relieve the Vendor of the responsibility to make good faith efforts. Vendors are not, however, required to accept higher quotes from DBEs if the price difference is excessive or unreasonable. The documentation of good faith efforts must include copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor was elected over a DBE for work on the contract.
- 6.1.5. Not rejecting DBE companies as being unqualified without sound reasons based on a thorough investigation of their capabilities. The DBE's memberships in specific groups, organizations, or associations and political or social affiliations (for example union vs. non-union employee status) are not legitimate causes for the rejection or non-solicitation of bids in the Vendor's efforts to meet the goal.
- 6.1.6. Making efforts to assist interested DBEs in obtaining bonding, lines of credit or insurance as required by the Department, the Vendor or to perform the scope of work.
- 6.1.7. Making efforts to assist interested DBEs in obtaining necessary equipment, supplies, materials, or related assistance or services.
- 6.1.8. Effectively using the services of available minority/women community organizations; minority/women Vendors' groups; local, state, and federal minority/women business

assistance offices; including IDOT's supportive services Vendors; and other organizations as allowed on a case-by-case basis to provide assistance in the recruitment and placement of DBEs.

- 6.2. In evaluating the Vendor's good faith efforts, the good faith efforts of other Vendors to meet the goal on this solicitation or similar contracts may be considered.
- 6.3. If the Department determines that the Vendor has made good faith efforts to meet the goal, the Department will award the contract provided that the Vendor is otherwise eligible for award.
- 6.4. If the Department determines that good faith efforts have not been made, it will notify the Vendor in writing that the proposal is not responsive. The notification shall include a statement of reasons for the determination. If the Utilization Plan is not approved because it is deficient as a technical matter, unless waived by the Department, the Vendor will be notified and will be allowed no more than a five-calendar day period in order to cure the deficiency.
  - 6.4.1. The bidder may request administrative reconsideration of a determination adverse to the bidder within the five working days after the receipt of the notification date of the determination by delivering the request to the Illinois Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764 (Telefax: (217) 785-1524). Deposit of the request in the United States mail on or before the fifth business day shall not be deemed delivery. The determination shall become final if a request is not made and delivered. A request may provide additional written documentation and/or argument concerning the issues raised in the determination statement of reasons, provided the documentation and arguments address efforts made prior to submitting the offer or proposal. The request will be forwarded to the Department's Reconsideration Officer. The Reconsideration Officer will extend an opportunity to the bidder to meet in person in order to consider all issues of documentation and whether the bidder made a good faith effort to meet the goal. After the review by the Reconsideration Officer, the bidder will be sent a written decision within ten working days after receipt of the request for consideration, explaining the basis for finding that the bidder did or did not meet the goal or make adequate good faith efforts to do so. A final decision by the Reconsideration Officer that a good faith effort was made shall approve the Utilization Plan submitted by the bidder and shall clear the contract for award. A final decision that a good faith effort was not made shall render the bid not responsive. The result of the reconsideration process is not administratively appealable to the U.S. Department of Transportation.
7. **Contract Compliance**: Compliance with this section is an essential part of the contract. The following administrative procedures and remedies govern the Vendor's compliance with the contractual obligations established by the Utilization Plan. After approval of the Utilization Plan and award of the contract, the Utilization Plan and individual DBE Participation Statements becomes part of the contract. If the Vendor did not succeed in obtaining enough DBE participation to achieve the goal, and the

Utilization Plan was approved, and contract awarded based upon a determination of good faith, the total dollar value of DBE work calculated in the approved Utilization Plan as a percentage of the awarded contract value shall become the amended contract goal. All work indicated for performance by an approved DBE shall be performed, managed, and supervised by the DBE executing the DBE Participation Commitment Statement.

7.1. No amendment to the Utilization Plan may be made without prior written approval from the Department's Bureau of Small Business Enterprises. All requests for amendment to the Utilization Plan shall be submitted to the **Department of Transportation, Bureau of Small Business Enterprises, Contract Compliance Section, 2300 South Dirksen Parkway, Room 319, Springfield, Illinois 62764. Telephone number (217) 785-4611. Telefax number (217) 785-1524.**

7.2. The Vendor may not make changes to its contractual DBE commitments or substitute DBEs without the prior written approval of the Department. Unauthorized changes or substitutions, including performing the work designated for a DBE with the Vendor's own forces, shall be a violation of the utilization plan and a breach of the contract, and shall be caused to terminate the contract, and/or seek other contract remedies or sanctions. The facts supporting the request for changes must not have been known nor reasonably should have been known by the parties prior to entering into the subcontract. The Vendor must negotiate with the DBE to resolve the problem. Where there has been a mistake or disagreement about the scope of work, the DBE can be substituted only where agreement cannot be reached for a reasonable price or schedule for the correct scope of work.

7.3. Substitutions of a DBE shall be permitted under the following circumstances:

7.3.1. Unavailability after receipt of reasonable notice to proceed;

7.3.2. Failure of performance;

7.3.3. Financial incapacity;

7.3.4. Refusal by the DBE to honor the bid or proposal price or scope;

7.3.5. Material mistake of fact or law about the elements of the scope of work of a solicitation where a reasonable price cannot be agreed;

7.3.6. Failure of the DBE to meet insurance, licensing or bonding requirements;

7.3.7. The DBE's withdrawal of its bid or proposal; or

7.3.8. Decertification of the DBE.

7.4. If it becomes necessary to substitute a DBE or otherwise change the Utilization Plan, the Vendor must first give notice in writing to the DBE subcontractor with a copy to the Department. The request must state specific reasons for the substitution or change. The Vendor must give the DBE five days to respond to the prime contractor's notice and advise the contractor of the reasons, if

any, why it objects to the proposed termination of its subcontract and why the Department should not approve the contractor's action. The Department will approve or deny a request for substitution or other change in the Utilization Plan within 5 business days of receipt of the request.

- 7.5. Where the Vendor has established the basis for the substitution to the Department's satisfaction, it must make good faith efforts to meet the contract goal by substituting a DBE. Documentation of a replacement Vendor, or of good faith efforts to replace the DBE, must meet the requirements of the initial Utilization Plan. If the goal cannot be reached and good faith efforts have been made, the Vendor may substitute with a non-DBE.
- 7.6. If a Vendor plans to hire a subcontractor for any scope of work that was not previously disclosed in the Utilization Plan, the Vendor must obtain the approval of the Department to modify the BoBS Procurement DBE Utilization Plan and must make good faith efforts to ensure that DBEs have a fair opportunity to bid on the new scope of work.
- 7.7. A new BoBS Procurement DBE Participation Statement (BoBS 2575) must be executed and submitted to the Department within 5 business days of the Vendor's receipt of the Department's approval for the substitution or other change.
- 7.8. The Vendor shall maintain a record of all relevant data with respect to the utilization of DBEs, including but without limitation, payroll records, invoices, canceled checks and books of account for a period of at least 5 years after the completion of the contract. Full access to these records shall be granted by the Vendor upon 48 hours written demand by the Department to any duly authorized representative thereof, or to any municipal, state or federal authorities. The Department shall have the right to obtain from the Vendor any additional data reasonably related or necessary to verify any representations by the Vendor. After the performance of the final item of work or delivery of material by a DBE and final payment to the DBE by the Vendor, but not later than 30 calendar days after such payment, the Vendor shall submit a statement confirming the final payment and the total payments made to the DBE under the contract.
- 7.9. The Department will periodically review the Vendor's compliance with these provisions and the terms of its contract. Without limitation, the Vendor's failure to comply with these provisions or its contractual commitments as contained in the Utilization Plan, failure to cooperate in providing information regarding its compliance with these provisions or its Utilization Plan, or provision of false or misleading information or statements concerning compliance, certification status or eligibility of DBEs, good faith efforts or any other material fact or representation shall constitute a material breach of this contract and entitle the Department to declare a default, terminate the contract, or exercise those remedies provided for in the contract or at law or in equity.
- 7.10. The Department reserves the right to withhold payment to the Vendor to enforce these

provisions and the Vendor's contractual commitments. Final payment shall not be made on the contract until the Vendor submits sufficient documentation demonstrating compliance with its Utilization Plan.
